They have a clean & very creditable place with all appointments up to date & no doubt will enjoy a good patronage. They have postponed their grand Opening to next Saturday night. Everyone is invited to esp. be present at that time..."

*Right Rev. Bishop Grant visits Butte/On Saturday at 10 o'clock, Mr. C.F. Jones & a number of his friends, also the guest of honor, Bishop Grant, with the hostess boarded an

observation car & took the interesting trip over the north sides of the city, making the tour of Walkerville & Centerville & out to the Gardens where the special attractions afforded much pleasure. Among the other participants were Mrs. C.F. Doris, Mrs. M.E. Doris, Mrs. C.P. Smith & Mrs. E. Johnson."

It was a gem in thought & delivery & was enthusiastically applauded when mention was made of the points that must concern the race. The speaker told of the customs & habits, & manners of the natives & others who live in Africa...He strongly urges the higher development of industry among the Negro race, & above all refrain from the congested districts of the larger cities, making mention of the untold resources offered in the sparely settled districts throughout the Western states...The Bishop was escorted about the city in company with a committee which took in the principal parts of interest on the "Seeing Butte Car," while he was the guest of the entire colored population of the city..."

The interior was beautifully arranged; the beautiful punch bowl service was supurb [sic]. The evening was spent in a social way, conversation, music, etc. Mrs. Harrison as a hostess proved to be one of the very best & all left with a kindly feeling for her welcome & hospitality." Fletcher Lodge, AF & AM "but at the time that the procession should have started from the undertakers' on its way to the church, instead of the lodge, she received a message from the W.M. of the Lodge that under the circumstances they would not take charge of the body. JEFFERSON OF BUTTE TO the Dallas Express editor: "...I've about reached the conclusion that there is not a city in the US of the size of butte that has as many peculiarities as butte. Just to think that a few days ago there were 30,000 miners who threatened to go out on a strike & at that time the city was at fever heat with excitement...Next came the Telephone Girls' union & tied up the town for a few days, & now the are at work again. I guess there are nearly 100 unions in this city...in fact everything & they all go on a strike whenever they see fit...But what I wanted to say about the unions is this,--the only union among all of them that give me as much trouble is the Mail Carrier's Union. They went on a strike & to think of it,--80,000 people going to the Post office for their mail...we will have as we have had, the best town in the US for making money. I am jus getting the kinks out of me from the big snowfall we had last Sunday, when the snow covered the earth from 8 to 12 "...This is a great country. I live 7,767 feet above the sea. I am up among the stars. Our people in this part of the country are not doing as I would like to see them, do, but I cannot talk anything to then for their good..."

*Locals: "Wm Hutchinson & Mrs. Marietta Pope of Anaconda were married in this city Wednesday. They left Thursday morning for Spokane..."

*Havre Notes: "10 July 1907 At last after many trials & tribulations the Afro-Americans have a church in which they can seat themselves with pride. The Rev. Redd & wife visited our little city some weeks ago staying with us 3 days [before returning to Great Falls] The results was that the church was purchased—a fine corner lot with a building on it at the corner of Third St. & Sixth Ave in the east part of town. They remodeled the building, papered & painted the inside, & put in the electric lights & an organ. ..Mrs. O.R.D. Welborne has opened the finest café in the city on first Street next to Hotel Havre...Mrs. M.J. Conley has established a dairy on the ranch, two miles from the city, & now supplies a large number of Havreites with the best milk, cream & buttermilk..."

But just let a real nice, intelligent colored man or woman run a first class business you will hear the northern white brother say, Oh it is too bad that he or she is colored, they ought to have been a Jew...my dear brother drop the Negro problem let the Negro fight his own problem...", address 15 State Street, saleswoman in family's second hand store

*"Locals...J.H. Waggoner has opened up a cleaning & pressing establishment at 105 Broadway [Crown Clothes Cleaner on Hoback two months later]...Mrs. J.H. Waggoner & children arrived last week from Missoula...Miss Vera Simmons is now holding down the position as cashier at the Temple Café [in basement of Masonic Temple, 1914-15 Lewistown C.D.] in Lewistown of which Wm. R. Holland formerly of this city is proprietor...Lucien Foreman, formerly of this city, later of Lewistown, erstwhile owner of the Temple Café is reported as a resident now of Chicago...L.V. Graye, formerly of this city is making good in San Francisco & is conducting a paying business such as he conducted here at the time he left...."

Gordon of White Sulphur Springs was over on a flying visit this week...Mr. & Mrs. Edward Miller of Missouri came over from Missoula Saturday to attend the funeral of their niece Miss Teresa York...J.B. Anderson of Washington, DC was in the city last week. He is the soliciting manager of the Bernice Red Rock Mining Co, half way between here & Butte. This company has a [illeg.] streak of ore which they are shipping. They intend to develop the claim & Mr. Anderson will shortly go East to put the stock on the market. Even over in Butte a Socialist mayor has done the unprecedented thing of appointing a Negro on the police force..." [delegates include from Helena: Nathaniel Ford, Arthur Palmer, B.F. Hooper, J.E.W. "Locals...To those who thought they would feast on at least a column of scandal anent recent happenings in this city in this issue they will be sadly disappointed...Mrs. Dinah Brooks made a business trip to Lewistown this week, returning Thursday. We will be around this week, please be ready to meet us...We do not share in the belief of some of our friends & some of the members of the Colored Progressive Club that Cap. Adamson as constable has been unfaithful to a trust, that he is not sincere, etc. we, of course, can be mistaken & if he is not all right, we are. We have at all times found him courteous & obliging as an officer...We do not understand that a man's color ought to cut much figure as to him watering a lawn & caring for a park. But according to Ward Cole, we understand that it does, as he was discharged by the park commissioners on the east side for no other reason than that he was colored..."

*Page 1: "GOOD CITIZENS MOVEMENT. The colored citizens of Helena taken the initiative in a movement al st week which will redound to their credit more than all the efforts of organization that they have ever attempted. The idea is largely to the extent that colored element condemn immorality, but these strong resolutions passed at this meeting against the vagrant pimp macques & secretaries told in no uncertain manner the sentiment that has been crystallized in this city against that element. They elected officers & also a committee of 5 to confer with the proper officials to the end that the community should be ridded of this undesirable element. The committee appointed is a strong one that will do their utmost...The meeting met at the Masonic hall at the foot of Broadway was called to order by B.F. Hooper [1st vice president]...A.J. Walton [second vice president. Over 50 names were enrolled as members...work all along the line of racial progress. Morally & financially. The most important after the moral issue is the business outlook. a committee which will look out after the business opportunities for members of the race..."

*Page 1: "the recent editorial in the Plaindealer in which we took occasion to flay the secretaries that infest the city at this time brought down on us the wrath of that gentry & some of their champions, but we have nothing to take back. We still say that t the present time they are a menace to the community & should be suppressed. And there is something wrong why they are not. We have been told that somebody is getting paid for protection & also that one of the old timers stands so well that he can fix things for them. In the meantime, they grow more bold & seem to flourish like the green bay tree. And Nero fiddles while Rome burns..."

*"Locals...Rev Thompson who is a regular AME missionary delivered a very interesting lecture on the mission work in Africa from which continent he has only recently been.
